FINISH TO BE:
SATIN AND LACQUERED

GLASS TO BE: CLEAR
1/2" TEMPERED FLOAT FOR WINGS (FACTORY GLAZED)
9/16" BENT LAMINATED FLOAT FOR ENCLOSURE
13/16" LAMINATED FLOAT FOR CEILING
GLASS TO MEET ANSI Z97.1 AND 16 CFR 1201.
ALL TEMPERED GLASS TO HAVE SAFETY LOGOS.
IF ADDITIONAL LOGOS ARE REQUIRED PLEASE SPECIFY.

CONTRACTOR NOTE:
CONTRACTOR TO PROVIDE A 25 1/2" x 3 13/16" DEEP CUTOUT TO ACCEPT SPEED CONTROL UNIT AND FLOOR RING.

- FLOOR MOUNTED MANUAL SPEED CONTROL UNIT.
- OVERHEAD MOUNTED PIVOT BEARING.
- FULVIEW II PANIC PROOF BOOK-FOLD MECHANISM IN COMPLIANCE WITH ALL APPLICABLE REGULATIONS.
- LOCKS: CONCEALED REV. DOOR TYPE TWO (2) REQUIRED INSTALLED AT BOTTOM RAILS OF TWO ADJACENT WINGS FOR INTERIOR LOCKING.
- CYLINDERS: STANDARD SIZE MORTISE TYPE, TWO (2) REQUIRED PER REV. DOOR UNIT, TO BE SUPPLIED BY OTHERS TO C.D.C. FOR SHOP INSTALLATION.
- PUSH BARS: 1" DIA. BRONZE, FINISH TO MATCH DOOR.

BOOK-FOLD TENSION IS NOT PRESET; IT MUST BE ADJUSTED TO MEET BUILDING CONDITIONS.
